-Only \$3,800 in checking account. If not for the deal that Mark Wilson worked out with OPRT we would be overdrawn at this time.

-The financials are wrong because of Square (\$500 discrepancy) so the correct ones will be added at a later time. We will officially stop using Square by January 2020.

-2020 budget being looked at December 14, 2019 by Taneka and Keith a very rough pass at it so the BOD can also comment just keeping in mind this is a very rough draft only.

-Mark would like to know what the projected insurance will be for 2020 as it seemed low - Mark is looking into a prorated amount from 7K to 11.6K for adding additional umbrella.

4) New Business

a) Revoked reciprocal licenses SOP - Mark (move to Feb or March)

-This needs to be discussed in either February or March 2020 and not right now.

b) Quick recap and feedback on change to more rapid minutes prep-Tullio

-Tullio will send out a request for feedback and put in the subject line "vote needed" and try to get out to the membership within two weeks following the BOD meeting.

c) Determine desired Chicane rounds for 2020 - Alex (provided by email)

June and July 2020 for chicane rounds - May and August at WMRRA - Vintage has typically been August and would like to keep it August for continuity. Tullio - making a motion to have two chicane rounds instead of just one chicane round - 2nd Taneka - Discussion - no discussion - vote is unanimous. Tullio proposes motion for June and July to be chicane rounds, Mark 2nd. Discussion: - vintage days would be in July instead of August - **Vote: Unanimous.**

-Vintage should be in July - NRS is in April and 2nd NRS would be July.

d) Banquet Planning - Patty

-Patty has not asked for help yet for banquet because there is no SOP for Norse Hall yet. Food budget was proposed at \$3,000. Elephants has been decided it is \$3,585 for food. Patty would like to give them a 50% deposit. Should anything concerning follow-up discussion about No Brakes be here?? No. We will proceed with Elephant's for 2020 and engage with No Brakes much earlier for next year's banquet.

e) Bylaws changes for BOD member residential radius, BOD 2 year terms, BOD meeting changes (email discussion)

Discussion continued to the next board meeting, prior to GM meeting.

f) WMRRA alignment process

-Email is being prepared regarding alignment on safety concerns/alignment. Taneka to complete the list prior to presentation to WMRRA.

-Memorandum of Understanding signed by Mark was provided to WMRRA, but has not yet been signed and returned. They will be addressing it soon according to follow up by Mark.

g) 2020 Trophy planning - Justin

h) General membership Meeting planning - Mark

-General Membership Meeting is Tuesday February 11, 2020 at Ringlers 1900 - Indy will call to schedule.

-Usually held at Kennedy School in 2nd week of March. Justin will set this up and follow up with Patty off-line.

-Jesse at APEX Bar & Grill has agreed to be the Title Sponsor again for 2020. Mark wants to follow up with him prior to going into more detail. Mark committed to providing more value than what he feels like he has received from OMRRA in the past. Discussion is ongoing.

-Patty will give Justin information on how to set up volunteer meeting at the Kennedy Center. 2nd week of March is typically when this meeting happens.

-2020 season referees will be Daric Cheshire and Jason Iverson.
