Looking into motorcycle specific instruction for EMTs. Shannon has MotoAmerica medical tech and is familiar with that training process. Full daily training may be impractical but a 15 minute daily procedure can hit the important parts. Potentially will be training video. May look into dropping from 2 ambulances to 1 ambulance as local ambulances transport unless the patient is coding, the OMRRA attorney will be consulted before any changes are made.
